Explanation for Categories

Court: Circuit court / Municipal court hearings and trials.

Court Cancellation: Scheduled court that is cancelled after business hours the day prior of the scheduled court appearance.

Drug Inv: Drug Unit operations – surveillance, drug buys, search warrants.

Call-In: Off-duty officers called in due to call volume, major crimes, and critical incidents.

Busy: Officers working past the end of their scheduled shift due to calls (crashes, disturbance, arrests etc.), priority reports or reports required before officer is on scheduled day off.

Meeting: Department meetings, Explorer Program, Citizen's Academy, Crime Prevention, Committees.

Grant: Traffic enforcement grants, grant funded training. As stated, these are funds that are reimbursed to the City by the Grant Administrator.

Fill-In: Overtime to bring us to minimum staffing when we are short for any reason not directly related to being one full-time officer position short. Sick time, court, training, family leave.

Training: Mandatory annual training in use-of-force (firearm, Defense and Arrest Tactics, electronic control device), emergency vehicle operation, tactical team training, legal update.

Community Talk: Presentations by officers on varying topics (crime prevention, drugs, child safety, alarm / robbery procedures) to schools, businesses, clubs / associations, and the general public.




