OLD BUSINESS

CONSIDERATION OF RECOMMENDATION REGARDING CONTRACT BETWEEN WASTE MANAGEMENT AND THE CITY OF MARINETTE FOR AUTOMATED COLLECTION WITH 64- GALLON CART SERVICE

Aldersperson Polzin moved/ Keller seconded and after further discussion Aldersperson Oitzinger made a friendly amendment to add **contract approved contingent upon** (Polzin & Keller concurred) Exhibit A Specifications included in the contract moves item that states “Plastics not listed above including but not limited to those with symbols #3*, #4*, #6*, #7* and unnumbered plastics, including utensils” be moved from the Non-Recyclables paragraph into the Recyclables paragraph, and language stated in the contract that all pick up currently in place will remain the same as far as Alley or Curbside pickup and upon a call of the role **motion carried** by a vote of 9 ayes to 0 nays to **approve** the contract with Waste Management and the City of Marinette for Automated Collection with 64 Gallon Cart Service with the stated amendments to the contract.

CONSIDERATION OF RECOMMENDATION REGARDING BID RESULTS FOR JCI WATER MAIN LOOP.

Included in the packet is a signed letter by Mayor Genisot dated February 10th stating that the City of Marinette is withdrawing from the water summit and it further appears based on the water study conducted by Stand Associates, Inc. that the Town of Peshtigo is considering water service from the City of Peshtigo and no longer considering the City of Marinette as a source for water.
