## ORDINANCES

### **DISCUSSION AND POSSIBLE ACTION REGARDING ORDINANCE NO. 2518-AMENDING MMC 2.0500 PERTAINING TO ETHICAL STANDARD.**

Alderspersons [Kowalski](#) moved/[Polzin](#) seconded and upon a call of the roll the **motion passed** by a vote of 8 ayes to 0 nays to **approve** as presented with the following amendments:

Remove elected and add Public in front of officials and add Citizen Boards and Committees.

Add Department Heads are governed in the Employee Handbook according to Personnel & License Committee regulations.

Add Public Safety Officials are governed by Police & Fire Commission.

Aldersperson [Polzin](#) amended the motion/ [Kowalski](#) seconded to add language Aldermanic District Ward members instead of Aldersperson and upon a call of the roll the **motion passed** by a vote of 8 ayes to 0 nays to **approve**.

After further discussion Aldersperson [Oitzinger](#) moved/ [Karban](#) seconded to amend the motion to read the Ethics Board shall consist of 3 Citizen members and 1 citizen alternate staggered for a 3-year term and upon a call of the roll **motion passed** by a vote of 5 ayes to 3 nays ([Klegin](#), [Kowalski](#) & [Polzin](#)) to **approve**.

Aldersperson [Oitzinger](#) moved/ [Mikutowski](#) seconded and upon a call of the roll the **motion passed** by a vote of 8 ayes to 0 nays to **approve** amending 2.05101 item B to read "The impositions of any of these sanctions will require an affirmative vote of 2/3 of the entire Common Council". After no more amendments were made and upon a call of the roll **motion passed** by a vote of 6 ayes to 2 nays ([Kowalski](#) & [Klegin](#)) to approve Ordinance No. 2518 Amending MMC.2.0500 Pertaining To Ethical Standards with the approved amendments.
