Street Opening Permit Conditions

Permit No.: 2025 -

The attached permit is approved with the following conditions:

- This permit authorizes the Permittee to only perform work within City of Marinette right-of-way as described and/or shown on the attachments. No other work is allowed under this permit.
- Permittee shall be responsible for notifying Diggers Hotline before starting any work.
- If any work will be performed in the street, contractor is responsible for notifying local emergency personnel at least 24-hours before road closure by calling Marinette County Central Dispatch at 715-732-7332.
- Permittee shall provide all required traffic control, including detour routes and flagging.
- Contractor is responsible to maintain the street opening at all times and shall keep the area safe.
- All street surfaces disturbed during construction shall be permanently restored with like materials, either hot mix asphalt or concrete pavement, according to City of Marinette standards.
- Lawn restoration shall consist of topsoil, seed fertilizer and mulch, according to City of Marinette standards.
- Permittee shall warranty all restoration for a period of 12 months from the time the restoration is completed and approved by the City.
- Any damage to paved areas will be restored with like materials at the expense of the Permittee. This applies to ALL paved areas regardless of its pre-existing condition. The City will have sole discretion regarding the extent of required restoration. Concrete and asphalt restoration shall be done by a city-approved contractor.
- All restoration shall be completed within 5 working days from the time the work is completed. If the restoration is not complete in 5 working days, the city may restore the opening. The city will deduct the cost of restoration from the contractor's deposit. If the restoration cost exceeds the deposit amount, the permittee will be invoiced for the balance.
- Permittee shall comply with all federal, state, and local laws.
- Permittee shall comply with State of Wisconsin, Department of Natural Resources erosion control.
- All costs associated with the work under this street opening permit shall be the responsibility of the permittee including, but not limited to: street restoration, turf restoration, and any other repairs to damaged city property caused by work performed under this permit.
- Catch basins tapped for sump pump discharge pipes must be core drilled and the opening sealed with mortar. The end of the sump pump hose shall be installed flush with the inside wall of the catch basin. The pipe connection must be inspected by the City before backfilling.
- Any sidewalk removed shall be saw cut at existing joints. Replacement sidewalk must be constructed on compact granular backfill. Replacement sidewalk must be poured concrete and installed by a city-approved contractor. Concrete mix must be preapproved by the city. Replacing sidewalk panels with previously removed panels will not be permitted. Jetting sump pump hoses or conduits of any type beneath sidewalks will not be permitted.
- Permittee must notify the City Engineering Department for a project inspection within two (2) days of completing all work, including lawn restoration. Call (715) 732-5134 to schedule the appointment.
